

The undersigned, desiring to form a corporation, not for profit, under Sections 1702.01 et seq., Revised Code of Ohio, do hereby certify:

FIRST. The name of said corporation shall be The Owensville. O. & Vicinity Local

Historical Society, Inc.

SECOND. The place in Ohio where the principal office of the Corporation is to be located is

Owensville, Ohio

Clermont

County.

(City, Village or Township)

THIRD. The purpose or purposes for which said corporation is formed are:

This Society is non-profit and exists to further historical education in Owensville, O. and vicinity and to encourage the continued preservation of our local heritage.

To this end the Society will maintain a museum to collect, preserve, and display historical items, encourage research, and promotes interest in our local history.

It will hold regular meetings, issue publication, including a Newsletter, sponsor programs in the schools, and cooperate with other organizations in the community and county interested in historical preservation and programs.

The Society Headquarters and Museum will be located in the Owensville Municipal Building in Owensville, Ohio.

- 2) The statutory agent for a corporation may be (a) a natural person who is a resident of Ohio, & (b) an Ohio corporation or a foreign profit corporation ilcensed in Ohio which has a business address in this state and is explicitly authorized by its articles of incorporation to act as a statutory agent. R.C. 1701.07(A), 1702.06(A).
- The agent's complete street address must be given; a post office box number is not acceptable. R.C. 1701.07(C), 1702.06(C).
- An original appointment of agent form must be signed by at least a majority of the incorporators of the corporation.
